1.1 INTRODUCTION

The pattern of legal education which is in vogue on India was transplanted by the English, after the establishment of their rule in India. Formal legal education in India came into existence in 1855 when the first professorship of law was established at the government Ephistone College. As majority of the population was rural and illiterate, the need was felt to bridge the gap between the existing law and the uneducated masses crying for justice, by rendering importance to formal legal education. In the year 1857, legal education was introduced as a subject for teaching in three universities in the presidency towns of Calcutta, Madras and Bombay. Thus, a beginning of the formal legal education was made in the sub-continent.

Legal education and research requires current information pertaining to various acts, decisions of court, whether it is high court or district court or Supreme Court. For this Library plays very important role in identifying, acquiring, organizing and disseminating information to the users of law system.

Information sources both print and electronic resources are accessible in the library. Kawatra (1988), defines "Information resources which include required and assigned reading, reference and bibliographical materials, basic journals and serials s well as any other library materials that users are accepted to be consult in their course of study or in the preparation of thesis and dissertation". The online databases like Manupatra – a legal online research database provides very useful source in the Indian context and so also the e-information sources like http://supremecourtofindia.nic.in/ and supreme court cases at http://courtnic.nic.in/supremecourt/caseno.asp are the important sources for the students, research scholars, faculty and advocates in the field of legal system in India. The extent of use of information sources both print and online sources and level of satisfaction among students is discussed in this study.
