Regularly, the initial two contacts are utilized to set up for an assault, an endeavor to coordinate the ball back over the net so that the serving group can't keep it from being grounded in their court.

The rally proceeds, with each group permitted upwards of three back to back contacts, until either (1): a group makes a slaughter, establishing the ball on the adversary's court and winning the rally; or (2): a group submits a blame and loses the rally.

The group that wins the rally is granted a point, and serves the ball to begin the following rally. A couple of the most well-known issues include:

1) Causing the ball to contact the ground or floor outside the rivals court or without first ignoring the net.

2) Catching and throwing the ball.

3) Double hit: two back to back contacts with the ball made by a similar player.

4) Four back to back contacts with the ball made by a similar group. net foul: contacting the net amid play;5) Foot blame: the foot traverses the limit line when serving

The ball is typically played with the hands or arms, yet players can lawfully strike or push (short contact) the ball with any piece of the body.

Various predictable systems have advanced in volleyball including spiking and blocking (on the grounds that these plays are made over the highest point of the net, the vertical hop is an athletic ability underlined in the game) and additionally passing, setting and concentrated player positions and hostile and protective structures.

VOLLEYBALL IN KARNATAKA

Volleyball was introduced in Karnataka during the early part of 20th Century, by the influence of Y.M.C.A. Madras to 1951.

The Karnataka State Volleyball Association was formed in July 1951, under the president of Sri. Eqbal Hussein, retired Judge of High Court of Karnataka and Sri. V.M. Rangaswamy was the Secretary to organize and popularize the game in the state.

As a major step of organization, the association began to from direct Association at the district head quarters, at that time 12 clubs were affiliated to the Association.

In the year 1954, Hassan formed the District Association and in the subsequent years, Tumkur, Mandya, Mysore, Bangalore and Kolar district formed the district association Karnataka State Volleyball association Karnataka state Volleyball association has 19 district volleyball association. Each district must have a minimum of seven teams to from a district volleyball association. The executive committee met in the year 1973 and passed a resolution that the state championship shall be open is the district association. These might actives the formation of district association and remain in the rules of the state association.
